# **Working Copy Board Meeting Deadwood**

The 2018 board meeting was called to order on By Frank S 07SEP2018 at 0905 CST in Deadwood, SD by Board Chairman David Moncada.

All board members and officers were present for the meeting which established a quorum.

The minutes from the 2017 board meeting had been provided to the membership for review. Tom Nash moved that the 2017 minutes be accepted as written, Chuck Ford seconded. It was unanimously carried.

Treasurer Lynn Walker next presented the treasurer's report. He reported that the association continues to maintain a steady financial position as compared to previous years. Since some of the expenses for this year's reunion have been prepaid he expects our finances to improve once the proceeds from the 2018 reunion are accounted for. Per the association balance sheet, our total liabilities and equity are \$34,516.93. A discussion ensued regarding what will be done with any money left in the treasury once the Association becomes non-viable. The decision was made to put off making a decision on the matter until at least the 2019 reunion. Dave Moncada moved that the treasurer's report be accepted as presented, Steve Deever seconded. It carried unanimously.

There were no old business discussion items.

The first item in new business were the four proposed changes to the Association bylaws. The board and officers discussed the basics of the changes. It was decided to make a full presentation to the membership at the business meeting later in the morning thus allowing for only one full description and explanation of the changes. Secretary Frank Svensson will make the presentation to the membership.

Steve Johnson discussed our Ranger Hall of Fame nominees and our progress with their applications. Steve described some of the changes that have been made to the selection process by the Ranger Hall of Fame. One of the major changes is the determination of how a candidate has carried the Ranger ethos into their subsequent undertakings as soldiers and civilians. He made the case for us to consider Tom Nash as a possible candidate. Gen. Mark Brennan (ret.) was also suggested as a possible candidate. Tom Nash had discussed it with Mark and found that he is not interested in being nominated because he feels that there are too many generals and other officers in the RHOF already. Shawn Ranahan moved that the Association move forward with an application for Tom Nash's induction into the RHOF based on Tom's approval. Steve Deever seconded the motion. Tom Nash recused himself from the vote due to the conflict of interest that would be created with the remainder of the board members approving the motion unanimously.

Chairman Moncada briefed the board regarding the LRRP/Ranger Heritage Project. The Project is an effort to gather as much history in the shortest time frame possible regarding the service of LRRPs and Rangers in Vietnam. Dave has volunteered to be the Association point man for the Project. Dave requested that our members send him any and all experiences that they might want to have in-

The next item discussed was the 2019 reunion. For the first time in our history we don't have a proposal for the reunion scheduled to be in the West Coast region. The possibility of reaching out to one of our members who lives in Seattle was discussed with the thought being that we would hold the reunion near Joint Base Lewis/ McChord where the Second Ranger Battalion is based. Steve Johnson then presented an alternative to having the reunion on the West Coast. The RRA will be holding their reunion at Ft. Benning celebrating the 45<sup>th</sup> anniversary of the forming of the battalions. The RRA has already laid the ground work regarding hotels and other accommodations and activities making it cheap and easy for our Association. The board discussed the proposal at length. The decision was made to present both proposals to the members at the business meeting and make a final decision at that time.

The board had an extensive discussion regarding meals provided by the Association for members and their guests.

Tom Nash briefed the board regarding the dangers of liver fluke for Vietnam vets. Liver fluke is a parasite that apparently was contracted as a result of eating under cooked fish. There is a test that a person can request their doctor to order that will determine if liver fluke is an issue. Tom will also brief the membership during the business meeting.

Chairman Dave Moncada informed the board that he has been diagnosed with prostate cancer. As a result of this he has decided that he would like to step away from active board membership for an undetermined period of time. This will necessitate an immediate search for a new board member. Final determinations will be made during the business meeting.

Dave Moncada presented a brief report regarding concessions. Sales continue to be very slow probably because we're getting old and we by now have pretty much everything that we want that has been in past inventories. Dave suggested that we hold steady with the items that are currently in our inventory. He also informed the board that he would retain his position as concessions manager. He provided the board with a breakdown of costs and income.

Tom Nash briefed the board regarding a change to the cost of purchasing bricks for the Ranger Memorial. The original person who was engraving the bricks has passed away and as a result of that his business has changed hands. Since this occurred the cost of engraving a brick has increased from \$50 to \$150 per brick. Tom encouraged anyone who doesn't have a brick and wants one to buy it soon

Shawn Ranahan requested that a sign-in sheet be provided at the business meeting to provide information regarding attendance at this year's reunion. He will provide this sheet and encourage our members to sign in.

Chuck Ford moved that the board meeting be adjourned. Shawn Ranahan seconded the motion. The board passed the motion unanimously. The meeting adjourned at 1020 CDT.

## **Working Copy General Members' Meeting**

Board chairman Dave Moncada opened the Association general business meeting at 1030 in Deadwood, SD. Treasurer diers and civilians. He informed everyone that the board had ap-Lynn Walker confirmed that we have a quorum of members in attendance allowing us to conduct business.

Following this there was a discussion about what to do with any funds that remained in the treasury when the Association ceased to be viable. The end result of the discussion was to put the decision off until a subsequent business meeting thus allowing for thoughtful member input on a final decision.

Secretary Frank Svensson made a presentation to the membership regarding changes to the association bylaws. The changes are designed to realign the reality of how we've been operating to what the current bylaws require and to address some requested changes to the publication of Sua Sponte.

The first proposed change was to Article Three, Meeting of Members. Under the existing bylaws the Association is essentially tied to July 4<sup>th</sup> as the anchor date that determines when business meetings must be held. The proposed change would define the determining factor as a calendar year thus allowing us to have our reunions and required meetings at any time during any given calendar year. The second proposed change addresses the bylaw requirement in Article Four, Board of Directors for nine (9) board members. The proposed change would reduce that number to five (5).

The third change addresses the current position requirement for a secretary/treasurer in our bylaws. This is in Article Five, Officers. The proposed change would split that position and create both a secretary and a treasurer's position.

The fourth and final change is to the Sua Sponte Operating Rules. The proposed rule changes allow the editor/publisher to produce Sua Sponte in any medium as selected by the editor. It also allows the board to select how often it would be published. Questions were asked and answered.

After this presentation Chairman Moncada asked for a vote on the proposed changes as presented. Al Stewart moved that all changes be accepted, Rich Kaiser seconded. The motion carried unanimously.

Steve Johnson briefed the membership regarding our Ranger Hall of Fame nominees and our progress with their applications. # **"WAR IS COMING"-FATHER JOHN DANE**

Here in England there are many controversial issues these days – but then again, where in the world aren't there any controversial issues?

There was a march in London just recently by folks we call "tree huggers", and you know, that class of young people we love to call "snowflakes". Anyway, they were demanding immediate action to prevent global warming (or whatever they are calling it these days) and their demands were noisy, predictable and a bit disturbing.

The predictable bit came out during the usual interviews carried out by the British fake news, you know: they didn't want a Brexit as they believe in unlimited immigration and open borders. And that all industry should be closed down in order to clean up the air. And all aircraft should be grounded to stop the pollution and depletion of the ozone. And I suppose we should all sing "Kum ba Yah" around a (presumably imitation) campfire while everyone starved to death! Predictable!

The disturbing bit the media reported centred on some interesting opinions spouted by the more spotty-faced of the activists: that all "useless" pensioners should be subjected to euthanasia and thus allow the dwindling and precious resources of the fragile world to be safeguarded and redirected to the more "needy" and "deserving" classes (the "snowflakes" in case you missed it). According to this group, and the media who repeated it, the questions about euthanasia in Parliament should not be about a "right to die" but rather should be one of a "duty to die". In other words, Britain should be just like Holland and Belgium with euthanasia on demand. Look how well that's working out for them!

Last night I watched a smashing video: "Saving Private Ryan." Just 75 years ago, the Rangers, as depicted in that film, had no qualms about putting themselves in the line of fire for the greater good. But as I watched the film, the noise of the global warming nutters echoed in my head and I couldn't help but wonder what those early Rangers would have made of that lot of "snowflakes" protesting in London a couple of weeks ago.

It occurred to me that those noisy young twerps waving their placards and shouting their slogans have never gone hungry – although most of them have never worked a single day in their lives. And more: they have never paid a penny of tax, but the welfare state has always provided them with a state-provided roof over their heads so they've never had to sleep rough in a field or anywhere outside of their own warm and comfortable beds. And although they have never contributed to the cost, the "free" National Health Service has never failed to provide them with free condoms and abortions and has always made sure a fully-trained

doctor treated their STD's whenever they demanded it. They have never had their lives threatened by anything worse than a common cold – and they have never, never had to make a decision greater or more important than deciding what to wear on a particular day.

Today I look around me and see what is happening - not only here in the UK – but all across Europe and I see things that I wish I couldn't see! I see people who were once proud of their great cultural heritage reduced to being merely "subjects of the state" rather than the proud "citizens" of a nation as they used to be. I see people who have no voice or control in what their own governments are doing and have to suffer an unelected bunch in Brussels overseeing the whole enterprise. I see free speech criminalised and even wrong thinking made verboten. I see people who are afraid to leave their own homes. I see barricades and conspicuous security in market places, shopping precincts, sports stadiums, concert halls, and even at libraries and museums. Every government office is now by guarded by armed police and protected by airport-style security systems at all the entrances. The population in England was disarmed 20 years ago, and yet London has a murder rate much higher than that of New York. Oh, and we have a Mayor of London who says all of this is "normal".

And if you said out loud that you are proud of your country or your nationality you will be immediately accused of racism, Nazism and fascism and any one of all the other "isms" of the present day. What's wrong with this picture?

Well, some 50 years ago, a rather interesting and controversial politician named Enoch Powell famously observed that the world had gone mad and that civil unrest and even war would come again to this island nation because of its open border policies.

Enoch Powell died on 8 February 1998, but as I look around me today, I can only conclude that he was right!


So yes, it will get worse before it gets better, but hasn't it always been thus?

## 2019 RENDEZVOUS BANQUET GUEST SPEAKER

### P. K. (Ken) Keen Lieutenant General, USA, (Retired)

Lieutenant General (Ret) P. K. (Ken) Keen is a native of Hyden, Kentucky. Following graduation as a distinguished military graduate from Eastern Kentucky University, he was commissioned as a 2LT in the Infantry in December 1974. LTG (Ret) Keen retired from active duty on 1 March 2013.

LTG (Ret) Keen is currently the Associate Dean of Leadership Development and a faculty member in Organization and Management for Emory University's Goizueta Business School in Atlanta, Georgia. In this role, he manages a school-wide leadership development program, which includes teaching crisis leadership; developing high performing teams; implementing a Coaching Fellows Program; and coaching in the Advanced Leadership Academy.

LTG (Ret) Keen served 38 years in the Army with over 11 years working and living abroad in the Republic of Panama, Brazil, Colombia, Haiti, Germany, Egypt, and Pakistan. Ken commanded a SCUBA detachment in 3<sup>rd</sup> Battalion, 7<sup>th</sup> Special Forces Group; a company and Battalion in the 82nd Airborne Division; Joint Task Force – Haiti following the Jan 2010 earthquake; as well as serving on three U.S. Embassy Country Teams leading all military forces in Colombia, Haiti, and Pakistan during crisis periods. He participated in Operation JUST CAUSE in 1989 as the Assistant S3 of the 75th Ranger Regiment; command-

ed a Ranger Task Force during Operation DESERT STORM in 1990, as part of a Joint Special Operations Command,, while serving as the S3 of the 1<sup>st</sup> Ranger Battalion; was the Executive Officer and Commander of 1<sup>st</sup> Ranger Battalion; and was the 11<sup>th</sup> Colonel of the 75<sup>th</sup> Ranger Regiment from 1999 to 2001.

LTG (Ret) Keen is a graduate of the Brazilian Command and General Staff College, Defense Language Institute - Portuguese Course, the University of Florida's Master of Arts in Latin American Studies program, and U.S. Army War College.

LTG (Ret) Keen also serves on several non-profit Boards in support of military veterans, education, and international humanitarian organizations. Ken is the Chairman of the Board of Trustees for the U.S. Army War College; on the Board of Visitors for the Western Hemisphere of Security Cooperation;



Board member for the Witness to War Foundation; Board member of the Community Organized Relief Effort (CORE); Chairman of the Ranger Hall of Fame Board; and Honorary Colonel of the 75<sup>th</sup> Ranger Regiment. LTG (Ret) Keen also serves as an Executive Coach with True Growth Leadership and as a Senior Fellow for the National Defense University. In 2016, LTG (Ret) Keen was inducted into the U.S. Army Ranger Hall of Fame and the National Reserve Officer Training Corps Hall of Fame.

LTG (Ret) Keen has been married to Mary Ellen Hume for over 44 years. They have a daughter, Marta Keen, a junior at Georgia State University; two sons, Dr. Ryan Keen and Jonathan Keen, who is married to Jennifer Wu; and have 2 grandchildren.


